Required Income Documentation:

1. Most recent paystubs
2. Most recent W-2 forms for all jobs.
3. Most recent filed tax return: 1040, 1040A, 1040EZ with any schedules you were required to file with your tax return for example:
 - a. Schedule A - Itemized Deductions
 - b. Schedule B - Interest and Dividend Income
 - c. Schedule C - Self Employment Income
 - d. Schedule D - Capital Gains and Losses
 - e. Schedule E - Corporation or Rental Property Income
 - f. Schedule F - Farm Income
4. Most recent filed business tax return (if applicable): 1040, 1065, 1120, 1120S
5. Need documentation for any supplemental income: Social Security, Welfare, Food Stamps, Child Support, 1099-M Forms, Workers Compensation, Unemployment, Veterans Benefits etc.
6. Louisiana TANF (Temporary Assistance for Needy Families)
7. Any other non taxable income received
